## MINUTES OF THE EXECUTIVE COMMITTEE MEETING HELD ON 15 OCTOBER 2013 AT THE ARSIPSO OFFICE, CRPF CAMP, RK PURAM, SECT. 7, NEW DELHI

A meeting of the Executive Committee of the Association of Retired Senior I.P.S. Officers (ARSIPSO) was held on **15/10/2013** under the chairmanship of Shri A.K. Verma, President. The following others attended:

**II.** It was decided to organize a social cum musical evening soon, in consultation with Shri Sankar Sen.

**III.** It was brought to the notice of the President that Shri Sankar Sen has written to India International Centre to jointly hold a seminar on the subject (Crimes against women). Also, that the Executive Committee, in its meeting held on 13<sup>th</sup> July, 2013, had decided to organize the seminar jointly with IIC on the topic 'Imperative of national security and tension it creates between observance of law and human rights'. During discussion most of the members felt that the topic suggested by Shri Sankar Sen has recently been discussed at various fora a number of times, and nothing of much significance is likely to come up in the

suggested discussion. Therefore, we should find out from Delhi Police what new measures have been implemented by them and with what results. This topic can be taken up for discussion thereafter, if required. Most felt that we should instead take up the topic decided by the Executive Committee in its meeting of 13<sup>th</sup> July, 2013, referred to above.

**IV.** It was also decided unanimously to increase monthly salary of Shri Dleep Mehta, Assistant in ARSIPSO Office, to Rs. 9,000/- (Rupees nine thousand only) w.e.f. 1<sup>st</sup> October, 2013.

V. Suggestion of Shri Rakesh Jaruhar to include 'Welfare activities related to security personnel' under rules governing Corporate Social Responsibility in the new Companies Act 2013 was approved. Shri Rakesh Jaruhar was requested to draft our communication and put up for forwarding it to the concerned authority in the Government.

**VI.** Shri K.K. Mitra's discussion with Shri A.K. Verma regarding matters relating to the Seventh Pay Commission was brought to the Executive Committee's notice by Shri A.K. Verma. It was decided to request Shri K.K. Mitra to prepare the memorandum in this regard separately. Shri Rakesh Jaruhar was requested to list out demand of pensioners for forwarding to Department of Personnel & Training (Pensions), so that recommendation can be made to DOPT to have a reference incorporated in terms of reference to the Seventh Pay Commission regarding concern of pensioners.

**VII.** Shri A.P. Bhatnagar, General Secretary of ARSIPSO, was requested to send letter of thanks on behalf of ARSIPSO to Dr. Kiran
